How was the action plan implemented:

1. The Lunch Time Learning aide was hired and worked with students to complete homework and help answer remaining questions about assignments.

2. The lower grade teachers came in early during the summer and sent appointment papers home to students to come in and complete their DRA assessments. This allowed the teachers to know the reading levels of students prior to beginning the school year.

3. Double Dose aides were hired and led the program before and after school to help students who were struggling academically. The students on track 2 came at 8:00 a.m. and the track 1 students stayed at school from 2:15 to 3:30 p.m. in order to receive academic interventions.

4. Forbes was able to purchase the Utah Write software that allowed the 3rd-6th grade students to practice appropriate writing skills and prepare for the Direct Writing Assessment.

5. Forbes purchased two Chrome Book carts that were shared by the upper grade classes. This allowed the upper grade students to improve their use of technology and prepare for SAGE testing that was completed on the Chrome Books.

The reason for the carryover of \$7,308 comes from the area of salaries and benefits.
