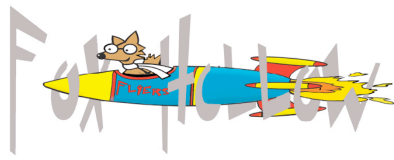

## WAIVER AND RELEASE OF LIABILITY AGREEMENT

### Waiver and Release

In recognition of the risk of injury while participating in Fox Hollow Elementary Walk-a-thon 2015 (Event), and as consideration for the right to participate in the Event, I hereby knowingly and voluntarily enter into this Waiver and Release of Liability Agreement, and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Event. This is binding on all heirs, executors, administrators, assigns, volunteers, or personal representatives. I hereby release and forever discharge Fox Hollow Elementary and its officers, director, employees, agents, representatives, successors, volunteers, and assigns from and agree not to sue for any and all liability or claims of any kind or nature, either in law or in equity, which hereinafter may arise as a result of my participation in the Event, whether any injury is caused by the negligence of Fox Hollow Elementary, the negligence of myself or third parties, the conditions of the course, or any other cause.

### Indemnity

I agree to defend, indemnify, and hold harmless Fox Hollow Elementary from all claims, causes of action, cost, expense, liability, losses, or damages for any property damage, property loss or theft, personal injury, disability, and/or death that may result from, or are in any way connected with my participation in the Event, including claims that Fox Hollow Elementary was negligent.
