We chose the Go Math Textbooks that we felt gave us the tools needed to teach the new core standards effectively in 6th Grade. The teacher team is using common formative and summative assessments they have created to measure student learning and to provide interventions to students as needed. We have provided professional development in June and August 2012 in mathematics and Response to Intervention strategies to implement the new standards.

This is a direct correlative program to Pyramid Response to Intervention given to us from the research Mike Mattos has and will provide to our teachers. This is a direct instructional program to address the needs of students both for interventions and extensions.

Mathematics Reading Writing

### This was the action plan.

- 1. Create Step-Up Program specifically by grade level.
- 2. Hire paraeducators to give instruction in large groups while teachers work with small groups of children.
- 3. Provide materials and supplies to create and use common assessments.

### Please explain how the action plan was implemented to reach this goal.

As a school we created a systematic embedded intervention program we call Step Up. Each grade level team provided targeted instruction to student who were identified through common assessments. Other students were provided enrichment and/or extensions during this time of intervention for other students. We hired paraeducators to provide the enrichment and extension section while teachers work with small groups of children in targeted instructional sessions. We provided instructional materials and supplies to facilitate the targeted instruction and the enrichment and extensions for students.

We will be using formative common assessments on a weekly basis to provide specific grouping for specific instructional strategies for the essential standards students need for interventions and for extensions.
