What we Saw

Sarah's group – went to a school with 500 students. It went well. They said that school needed a little more help from aides. The younger kids needed more time so they could open things. Once they get into the classroom, the students are better behaved. (not as

many students on the playground at one time). They gave us a handout that they gave to parents at the start of their switch. Supervision helps get students lined up. They had a color coded clock that had the times to go back to class. Problem with students needing to go to the bathroom. Still worked with inside days (can supervisions be done by aides during inside days?). Community play equipment. 6th graders would make sure the equipment is put away. Playground was pretty clean. Home lunches – they had a big cubby they would put their lunches. Each grade level would line up in abc order.

Fox Hollow – their lunchroom was a lot calmer than ours. They have doubled the veggie cart. Home lunches were similar as ours. The office said they have less headaches and injuries. They said the older girls were needing more time due to talking. 1/2 teachers would pick them up from their table. Other grades would line up at the door. Bringing less problems into the classroom. They needed a little more aide time. 15 to play 20 to eat. Mr. Finch said that our school might qualify for more aide time for lunch. We could possibly use teressa in a difference place than the bathroom. They would use the bathroom before going out to recess. The biggest

pushback was the older students saying that they didn't have enough time. They changed in April. Went through the line abc order.

Roverview—barcode cards. They are put in a chart. Students by grade level go and grab their card,, an aide squirts hand sanitizer, they go through the card reader. There would leave 2 helpers to clean up the tables.

Try doing it in abc order. Try it a month. Then try making some temporary cards to try.

Andrea-try having them come down the kindergarten hall to go to the lunchroom.

Zap/Detention—Zeros Aren't Permitted. Students go in and work on.

Angi—afternoon recess, have a school store they can buy a snack or bring one from home.

Peggy—talked with several teachers. One said the students were much calmer. Teachers need to be on-time getting their class.

Flow-Mr. Hunting made a chart of the current flow and how long students are in the lunchroom.
