Called to order by Kimberly at 3:50pm.

1. Review Goals:

We had a discussion and we agreed to modify our previously written goals as follows:  
Goal #1----81%-83% to 87%-89%. We are still improving by 2% just like the goal says. What we wanted the notes to reflect is that we all understand the percentages were wrong so we need to change those, but the goal does not need to be amended.

Goal #2. We like the way it was originally written but will be accountable for the way it is on the website now and that will be our accountability.

*All students in grades K-6 will participate in a writing program that is vertically aligned with the Utah Core State Standards and assessed using the Traverse Mountain Writing Rubric. Three assessment windows will be used to determine growth progress and final achievement of the writing goal: Fall for baseline data, Winter to measure progress toward goals, Spring for actual outcomes. Students in grades K-3 will show growth from Fall 2015 to Spring 2016 when assessed using the Traverse Mountain Writing Rubric. Students in grades 4-6 will show growth on the 2016 Spring SAGE ELA summative assessment. Students scoring 3-4 on the 2015 Fall SAGE ELA interim assessment will maintain those scores, and 50% of students scoring 2 will increase to a 3 and 50% of students scoring a 1 will increase to a 2 on the 2016 Spring SAGE ELA summative assessment.*

But we will submit for official purposes the following:

*Students in grades 3-6 will increase writing proficiency by 5% on the end of year SAGE writing assessment in 2016.*

2. We discussed proposed Trustlands expenditures

- a. We've already spent \$21,000 from our original total of \$65,446. We have \$44,446 left to allocate.
